WHAT IS AN INTERNSHIP?

An **internship** is a formative experience carried out in a company either in Italy or abroad. The intern, supervised by a company tutor, expands and enhances the knowledge obtained during the courses at University and verifies his/her own attitudes.

Two kinds of internship exist:

• Curricular Internship

The curricular internship is an activity carried out by students **enrolled** in Undergraduate, Graduate, and Master courses. This also includes interns that already graduated once but are <u>currently enrolled</u> in another Bachelor's or Master's degree. For this kind of internship, the monetary compensation is at the discretion of the company.

The *curricular internship* for <u>Bachelor's Degree and Master's Degree</u> must last between a minimum of **1 month** and a maximum of **12 months**.

The *curricular internship* for <u>Masters</u> must last a maximum of **6 months** and must end before the Master diploma.

• Extracurricular Internship

The extracurricular internship is the activity carried out by students who have graduated and who have finished their degrees. In this case the internship must last for a period of at least 2 months up to a maximum of 12 months and can be within 12 months from activated the graduation date. Based on the applicable Regione Lombardia regulations, for this kind of experience an allowance is established of a minimum of either €500 gross per month or €400 gross per month plus meal vouchers or canteen service (if a minimum of 80% presence rate is ensured by the intern). To be able to carry out the internship, the graduated student must be registered at the local Employment

Centres by filling out an official document called DID, "Dichiarazione di

Immediata Disponibilità al lavoro".

To activate the extracurricular internships outside of the Lombardy Region, the companies ought to contact directly the Employment Centres of the corresponding region.

HOW TO ACTIVATE AN INTERNSHIP?

In order to activate an internship, it is **necessary** for both the company and the student to be registered in **AlmaLaurea**.

N.B.: students are required to upload their and fill out their **updated CV** on the platform.

FOR THE COMPANY:

To sign in to AlmaLaurea, companies must follow this path:

Afterwards, in order to start internship activation procedure, the company will need to stipulate an agreement called "Convenzione" with IULM University and will insert the training project called "Progetto Formativo" directly on the platform. This document contains the description of the internship for each individual student, including the tasks they will conduct and the objectives of their internship experience.

• When can I start the internship?

It is possible to start the internship the moment that the University receives the "Progetto Formativo" signed both by the student and the company. After that, the Career Service Department sends an email to the students and to the company for the formal activation of the internship.

Can I substitute an optional exam with an internship?

For students enrolled in the following Degrees: "Relazioni Pubbliche e Comunicazione d'Impresa" and "Comunicazione, Media e Pubblicità" it is possible to request the internship's recognition to substitute an optional exam of 6 CFU University Credits. The internship must be <u>full time</u> and last at least <u>two months</u>. To register the corresponding Credits, the students must disclose a copy of the final internship certificate released by our department to the Student Services Office (Segreteria Studenti).

• Can I interrupt the internship before the established deadline? How?

Any internship can be interrupted ahead of time at any moment. The decision is made by the intern in agreement with the company. Then, the company will have to upload the official request by accessing the page with the "Progetto formativo" in the AlmaLaurea platform. We recall that the internship won't be validated unless it is carried out until the established deadline.

• Can I suspend the internship? How?

The intern has the right to a suspension of the internship in case of illnesses or injuries, for a period of 30 days or more, or in case the company should decide to close, for a

period of 15 days or more. The suspension has to be requested by the company. Only in these conditions will the student be able to make up for the days at the end of the internship.

• Can I prolong the internship? How?

It is possible to prolong the internship within the time limits established by law. The procedure is the same as for the interruption, but the extension request must be made on the AlmaLaurea platform <u>at least one week before</u> the scheduled deadline.

• Can I apply for internship offers at newspapers, television, or radio companies even though I am not enrolled in the Master's Degree in Journalism? Students of Bachelor's Degrees and Master's Degrees will not be able to attend internships related to editorial tasks at newspapers, television, or radio companies. This is due to the official convention stipulated between IULM University and the National Council of the Professional Association of Journalists. The agreement claims that IULM Journalism School is officially validated as a suitable seat for the journalists' traineeship ("praticantato") and for the National Exam for the Professional Journalists register. This restriction does not apply for the students enrolled in the Journalism Master.

• Howmany internship offers can I apply for?

The <u>students enrolled in Bachelor's Degrees and Master's Degrees</u> can apply for many different curricular internship offers, even at the same time.

The <u>students of Masters</u> can carry out <u>one single</u> curricular internship during the course: it has to be agreed upon with the director or coordinator of the Master,

and cannot last more than 6 months. It must finish before the final assessment of the Master.

In this case, the internship can be interrupted only in case of non-correspondence to the educational plan or peculiar situations which will be evaluated on an individual basis. In case of interruption, the student will have the possibility to activate a second internship: in any case, the total duration of the internship period (first and second ones) cannot exceed 6 months.

N.B.: after finishing the internship and only <u>after filling in the questionnaire</u> received by email, can the student request the final internship <u>certificate</u> by sending an email to <u>stage@iulm.it</u> by indicating name, surname, Student ID number, host company, and start and end dates of the internship.

N.B.: we remind students that before requesting an internship it is necessary to consult the internship regulations & rules of their corresponding degree, which can be found following this path:

MyIULM > Bachelors' Degrees (or Master's Degrees) > Internship and workshop

It's up to the student to guarantee to work the minimum number of months

requested by the internship regulation of his/her own degree for the recognition
of their University Credits.
