



**“PEER-TO-PEER” CALL FOR APPLICATIONS A.Y. 2022/2023  
RESERVED FOR STUDENTS ENROLLED ON THE 2<sup>ND</sup> YEAR OF THE BACHELOR’S DEGREE  
COURSE IN CORPORATE COMMUNICATION AND PUBLIC RELATIONS  
(ENGLISH CURRICULUM) FOR THE A.Y. 2021/2022**

**THE RECTOR**

- HAVING REGARD TO** Legislative Decree No. 68 of 29 March 2012;
- HAVING REGARD TO** the Independent Statute of the Libera Università di Lingue e Comunicazione IULM published in Official Gazette No. 59 of 12 March 1998 and amendments;
- HAVING REGARD TO** the University Academic Regulations issued by Rectoral Decree No. 11 738 of 18 September 2001 and amendments;
- HAVING REGARD TO** the Decree-Law no. 111 of 6 August 2021, and in particular article 1, paragraph 1, which provides as follows: "*in the Academic Year 2021-2022, the teaching and curricular activities of universities shall be predominantly carried out in presence*";
- HAVING REGARD TO** the Protocol for the regulation of measures to contain and contrast the COVID-19 of the Libera Università di Lingue e Comunicazione IULM, as revised in February 2022 and subsequent amendments;
- HAVING REGARD TO** the Decree-Law No. 24 of 24 March 2022, setting a process of gradual return to normality for all the sectors involved in the measures introduced during the state of emergency, including that of higher education;
- CONSIDERING** that, pursuant to the aforementioned Decree-Law 111/2021, universities will be allowed to continue their planning, obviously providing for activities "*predominantly in presence*", without affecting the related degree of autonomy and organizational flexibility in relation to the epidemiological context of reference;
- HAVING REGARD TO** the resolution adopted by the Academic Senate at its meeting of 23 February 2022;
- HAVING REGARD TO** the resolution adopted by the Board of Directors at its meetings of 27 January 2022 and 28 February 2022;

**HEREBY DECREES**

**Art. 1**

**1 contract** with a maximum duration of 130 hours per year is put out to tender, to be attributed to a student enrolled on the 2<sup>nd</sup> year of the Bachelor’s degree course in Corporate Communication and Public Relations (English curriculum) at Università IULM. The student is required to meet the following **essential requirements**:



- be regularly enrolled on his/her 2<sup>nd</sup> year of the Bachelor's degree course in Corporate Communication and Public Relations (English curriculum) for the academic year 2021/2022, provided that the assignee confirms his/her renewal of enrolment for his/her 3<sup>rd</sup> year prior to signing the contract;
- have acquired at least 65 credits of those provided for in his/her study plan within 16 May 2022.

The following are considered as **preferential requirements**:

- be an international citizen or have spent a period of study and/or work abroad which can be duly proved;
- interpersonal skills and good attitude towards interpersonal relations, possibly confirmed by a Professor of the University;
- previous experiences in similar activities;
- exams in the field of psychology passed with a grade not lower than 27/30.

#### Art. 2

The activities of this call for applications will be carried out in hybrid mode and, if conditions allow, predominantly in presence. If the conditions related to the pandemic state do not allow the presence in the premises, the activities can be carried out remotely. In this case, the student must possess his own PC and an adequate internet connection. Connection and telephone costs are not refundable.

The activities covered by this contract will be as follows:

- front-office: welcome newly enrolled students and provide them with organisational and/or administrative information at the Fresher's Desk;
- back-office: be in touch with students through the institutional e-mail address [tutor@iulm.it](mailto:tutor@iulm.it) (delegate access) and preparation of useful information materials for students;
- 1-to-1 or group meetings with freshers;
- support students in the preparation of exams on the recommendation of the DiversaMente, Disability and DSA service;
- collaboration with administrative offices and Faculties for the involvement of students in the activities of the University (conferences, guest lectures, events, etc.);
- management of student requests related to the Unibuddy Project through the Unibuddy online channel.

#### Art. 3

The activity will take place **from the 29<sup>th</sup> of June 2022 to the 15<sup>th</sup> of July 2023** and will include both lectures and exams periods. Training hours are included in the duration of the contract. Working hours must be observed respecting the indications provided for by the Guidance, Tutoring and Counseling Office and by the Study Abroad and International Recruitment Office, according to the particular needs of each degree course.

#### Art. 4

In addition to the initial intensive training, recurrent meetings with the Guidance, Tutoring and Counseling Office and with the Study Abroad and International Recruitment Office will be scheduled; the attendance of the student is **mandatory**.

In the event of negligence or failure to carry out the required tasks, detected by the Guidance, Tutoring and Counseling Office and/or by the Study Abroad and International Recruitment Office, the student may be dismissed from the assignment.



#### Art. 5

It is the case that the student loses the requirement of enrolment which enabled him/her to participate in the call for applications (e.g. **failure to complete the enrolment, failure to renew the enrolment for the following academic year, renunciation of studies, transfer to another University**), the student is dismissed from the assignment and s/he is required to notify the Guidance, Tutoring and Counseling Office and the Study Abroad and International Recruitment Office immediately. Likewise, the student shall renounce the contract - entirely or partially - in case of prolonged absences (e.g. **period of study abroad or internship**), not enabling him/her to duly carry out the required activities, unless the period of absence has been agreed on in writing, directly with the person in charge.

#### Art. 6

The **net hourly rate** to be awarded to the student amounts to € 11.00. For the purposes of payment, **the University card must be activated**. Every 50 hours of completed activities, the payment is made by the University Administration, after the person in charge of the service has certified the activities actually carried out. **Should the service be interrupted and should not be authorized the resumption of the activities in a future moment, no compensation is due in regard to the collaboration not provided.**

Only the hours effectively worked and properly accounted for will be paid off.

Pursuant to art. 11, paragraph 3, Legislative Decree No. 68 of 29 March 2012, services required to the student for the collaborations are exempt from taxes and in no way constitutes an employment relationship.

The University arranges at its own expenses, if necessary, accident insurance for those students who have been assigned the contract. The assignment does not give rise to any obligations to take out health or retirement insurance. The assignment does not give rise to any assessment for the purposes of participation in public competitions.

#### Art. 7

The awarding of contracts described in this call for applications shall not prejudice the allocation of other benefits by the Financial Aid and Tax Office.

The contracts referred to in this call for applications **are incompatible** with any other contemporary paid training activity, research, or with work services at Università IULM, including those on a temporary basis.

Remunerations coming from collaboration contracts referred to in this call for applications cannot be combined with the benefits referred to in art. 12, paragraph 3, Prime Ministerial Decree of 9 April 2001: University grants and scholarships aimed at the promotion of special international mobility programmes for study or work purposes, included the preparation of the Master's degree thesis, put out to tender by Università IULM.

Part-time collaborations **can be combined** with benefits arising from DSU Regional Scholarships, with *ad Memoriam* or *in Honorem* scholarships and with scholarships granted by public or private entities to IULM students.

#### Art. 8

Applications, to be submitted by filling out the relevant form available on the University portal at [www.iulm.com](http://www.iulm.com) (section "Life in IULM"), have to be sent at [tutor@iulm.it](mailto:tutor@iulm.it) **no later than the 6<sup>th</sup> of June 2022**.

According to the applications received, a basic ranking list will be created. The basic score will be calculated according to the criteria indicated in **annex A** of this call for applications. The basic score will be published before the interviews.

The interviews will be held online through the platform TEAMS, **between the 13<sup>th</sup> and the 16<sup>th</sup> of June 2022**. This call for applications constitutes the official convocation for acceptance to the selection interview, subject



to verification by the Offices.

The candidate must be available and have access to his/her IULM institutional e-mail address (@studenti.iulm.it) as indicated in the form, on the day and in the time slot set for the interview. For identification purposes and under penalty of exclusion, each candidate is required to prove his/her identity before the beginning of the interview, showing the same ID previously attached to his/her application.

The candidate may be excluded if s/he did not indicate IULM institutional e-mail address, fails to show, is not available on the scheduled day and time, or cannot prove his/her identity with a valid ID.

Under no circumstances will Università IULM be held responsible for technical reasons preventing the regular course of the interview.

No later than the **9<sup>th</sup> of June 2022** each candidate will receive at his/her institutional e-mail address the date and time of convocation for the interview; the link required to take part in the interview will be included in the e-mail.

During the interview, a minimum score of 0 points and a maximum score of 10 points could be awarded to each candidate.

Interviews will be given by a Commission: at the end of the meetings, the merit-based definitive ranking list will be created, inclusive of the basic score and the points attributed for the interview.

### **1. DATA PROCESSORS**

The **DATA CONTROLLER** pursuant to articles 4 and 24 of EU Reg. 2016/679 is the **Libera Università di Lingue e Comunicazione IULM**, whose headquarters are located in Via Carlo Bo, 1 - 20143 Milan, in the person of its pro-tempore legal representative.

### **2. DATA PROCESSED**

Personal and contact data, listed in this document, have already been provided for at the time of registration to the Libera Università di Lingue e Comunicazione IULM, referred to as Data Controller. In order to allow the interview to take place remotely, the relevant images and the voice of the candidates will be part of the treatment, using the candidate's webcam. Under no circumstances, images and voices will not be recorded nor broadcast. The candidate will be required to show his/her ID for the sole purpose of allowing the University to recognise him/her.

### **3. PURPOSE AND LAWFULNESS OF THE TREATMENT**

Personal data shall be processed lawfully, in compliance with the *provisions of art. 6, paragraph 1, letter b)* of EU Reg. 2016/679 for the following purposes:

- online interview;
- recognition process of the candidate;
- administrative management of the requests for participation and of the selection process;
- publication on the University portal of the merit-based ranking list, once the procedure has been completed.

### **4. DATA RECIPIENTS OR RECIPIENT CATEGORIES**

The supplied personal data may be transferred to the following recipients:

Likewise, the supplied data may be transferred to the following recipients:

- subjects providing services for the management of the information system and communication networks of the Libera Università di Lingue e Comunicazione IULM (IULM e-mails and web platform included);
- internal structures of the University in charge of managing the selection procedures.

Subjects belonging to the above-mentioned categories shall become the data processors pursuant to art. 29 of Reg. EU 2016/679, or shall operate in a completely autonomous way, as Data Controllers in their own right. The list of designated Data Processors is constantly updated and is available at the main office of the **Libera Università di Lingue e Comunicazione IULM**.

### **5. DATA TRANSFER TO THIRD COUNTRIES AND/OR INTERNATIONAL ORGANISATIONS**

Personal data will not be transferred abroad within or outside the European Union.

### **6. STORAGE PERIOD OR CRITERIA**

Data shall be processed automatically and/or manually, in a manner and with tools that ensure maximum security and confidentiality, by specifically appointed subjects.

Being these data already provided for at the time of registration or enrolment, these will be stored indefinitely with reference to art. 14, Decree of Ministry of Education, University and Research, No. 45 of 8 February 2013 (Official Gazette No. 104 of 5 June 2013).



Provided that the interview will take place online, under no circumstances shall the images and voices of candidates be recorded, stored by the University, nor broadcast.

#### **7. PROVISION AND REFUSAL OF PERSONAL DATA**

The provision of personal data for the purposes indicated in 3. of this information document is **necessary** in order to manage the activities concerning the selection described above. **Failure to provide personal data will make it impossible to provide the requested services for the purposes indicated in 3. of this information document.**

#### **8. RIGHTS OF THE DATA SUBJECT**

You shall be able to exercise your rights under articles 15, 16, 17, 18, 19, 20, 21 and 22 of EU Regulation 2016/679, by writing to the Data Controller, the Data Processor or the Data Protection Officer at the following address: [privacy@iulm.it](mailto:privacy@iulm.it). You shall have the right to obtain, at any moment, from the Controller, access to your personal data, and their rectification. Without prejudice for any other administrative and jurisdictional recourse, if you believe that the processing of your personal data violates the provisions of EU Reg. 2016/679, you have the right, pursuant to art. 15 letter f) of said EU Reg. 2016/679, to lodge a complaint with the Data Protection Authority and, pursuant to art. 6, paragraph 1, letter a) and to art. 9, paragraph 2, letter a), to revoke your consent to the processing at any time.
