



## Enrolment renewal procedures for second and third year courses

### Bachelor's and Master's Degree courses

#### Academic year 2025/2026

Online applications for enrolment on second and third year bachelor's degree courses and second year master's degree courses for the academic year 2025/2026 must be submitted from **August 1<sup>st</sup> to September 19<sup>th</sup> 2025** with payment of the first instalment to be made no later than **September 19<sup>th</sup> 2025**.

It is possible to renew enrolment through the reserved area in the [IULM University online services](#), under "Registration".

On applying for enrolment, students must read carefully the [Regulations for university fees and contributions for the academic year 2025/2026](#) for students enrolled in Bachelor's and Master's degree courses.

Students renewing enrolment in 2nd and 3rd year courses who wish to be allocated different contribution bands from the previous year must fill in the ISEE form online by **October 31<sup>st</sup> 2025**.

As the allocation of the contribution band is limited exclusively to the academic year of enrolment, the declaration must be submitted **annually**.

The enrolment fee and contributions are payable in three instalments:

- First instalment: by **September 19<sup>th</sup> 2025**. The payment slip will be available in the Online Services section from 1 August 2025.
- Second instalment: by **December 13<sup>th</sup> 2025** (the amount will vary according to the contribution band allocated). The payment slip will be available in the Online Services section from 2 December 2025.
- Third instalment: by **March 31<sup>st</sup> 2026** (the amount will vary according to the



contribution band allocated). The payment slip will be available in the Online Services section from February 16<sup>th</sup> 2026 (beginning of 2nd semester lessons)\*.

Any late payment will incur a penalty of €50 for single payments up to €3,000 and a penalty of €100 for higher amounts. In addition, all teaching and administrative activities will be blocked.

*\* Students who intend to withdraw from their studies and submit the withdrawal request before the date of issue of the second instalment (by November 30, 2025) or the third instalment (by February 15, 2026) will not be required to pay them.*

## **“Fuori corso” enrolments**

### **Bachelor’s and Master’s Degree courses**

#### **Academic year 2025/2026**

Applications for enrolment in years classified as “fuori corso” (Bachelor’s and Master’s degree courses) for the academic year 2025/2026 must be submitted from **August 1<sup>st</sup> 2025 to February 28<sup>th</sup> 2026** (from March 1<sup>st</sup> to June 30<sup>th</sup> 2026 with late payment interest charge).

It is possible in this case to carry out the procedure through the reserved area in the [IULM University online services](#), under “Registration”.

The enrolment fee and contributions must be paid in a single instalment.

Any late payment will incur a penalty of €50 for single payments up to €3,000 and a penalty of €100 for higher amounts. In addition, all teaching and administrative activities will be blocked.
