

## THE RECTOR

- CONSIDERING** Law no. 168 of 9th May 1989;
- CONSIDERING** Lombardy Regional Law no. 33 of 13th December 2004, containing “Provisions regarding Regional measures for the right to study, and in particular article 6, paragraph 1”;
- CONSIDERING** the Statute of Autonomy of IULM University (Libera Università di Lingue e Comunicazione IULM), published in the Gazzetta Ufficiale no. 59 on 12 March 1998, as amended;
- CONSIDERING** the University’s academic Regulations, issued by decree D.R. no. 11738 on 18th September 2001, as amended;
- CONSIDERING** the electoral Regulations, issued by decree D.R. no. 12700 on 22<sup>nd</sup> September 2003, as amended;
- CONSIDERING** the opinions of the student representatives regarding the choice of the period in which elections shall be held;
- AWAITING** the request from the current student representatives to carry out voting from 9 am to 6 pm.;
- CONSIDERING** the forthcoming termination of the electoral mandate of the student representatives in the various assemblies, and the need to proceed with the election of the above-mentioned representatives

## DECREES

1. Elections are called for the following student representatives for the two-year period 2019/2020- 2020/2021 (from the date of the Decree proclaiming the elected representatives to 31<sup>st</sup> October 2021):
  - one student representative on the Board of Governors, with the right to vote if elected by a quorum of participants no lower than a quarter of students enrolled. Otherwise, the student representative shall only have a consultative vote and will count towards the legal quorum only if present. This representative will also be called upon to act as the student representative for the Right to Study in relations with the Lombardy Regional Council;
  - one student representative on the Academic Senate;
  - three student representatives in each of the following Faculty Boards, one of which enrolled on a Master’s degree course:
    - Faculty of Communication, Public Relations and Advertising;
    - Faculty of Interpreting, Translation, Linguistic and Cultural Studies;
    - Faculty of Arts, Tourism and Markets;
  - one student representative on the Evaluation Board as an adjunct member;
  - one student representative on the Quality Assurance Board.
2. As an exception to the provisions of art. 22, paragraph 2 of the current electoral Regulations, and in acceptance of the request of the student representatives mentioned in the introduction, the elections will be held on **14th November 2019 from 9.00 am to 6.00 pm**. In the event of a turnout of less than 30% of those eligible to vote due exclusively to reasons of force majeure (e.g. a public transport strike), the Rector may, by Decree, authorise the continuation of the elections on the morning of the following day.

3. The two polling stations, located in IULM University, Via Carlo Bo, 1 shall be established by a subsequent Decree.
4. The administrative office in charge of proceedings shall be the Ufficio Affari Istituzionali, represented by Dr Giuseppina Mastro (tel. 02/891412321 email: affari.general@iulm.it).
5. Students who are regularly enrolled at IULM University, on undergraduate or postgraduate programmes, 1st and 2nd level Master's courses and research doctorates, shall be eligible to vote.
6. The candidates and voters for each single assembly is defined as set out in the Electoral Regulations cited in the introduction to this Decree.
7. **The electoral deadlines** are as follows:
