James Archibald, University of Montréal, Canada



James Archibald holds a doctorate from the University of Lille; he currently teaches translation at McGill University. His recent publications include "Pour l'engagement sociétal du traducteur", *Circuit 131* (2016), "Translating Politically Sensitive Texts in Multilingual Contexts" (Cambridge Scholars Publishing, 2016), "Managing Translation Quality in Multilingual Settings", *Circuit 133* (2017), and the Tagalog translation of the *Montreal Charter of Rights and Responsibilities* (2017). He directed the French edition of issues 87 (2016), 88 (2017) and 89 (2017) of *International Higher Education*, a journal published jointly by Boston College and the *Agence Universitaire de la Francophonie*. In 2017-18, he was a visiting professor at the Lebanese American University and the Université libanaise's Centre de langues et de traduction, where he gave the graduate seminar in translation studies. A Chevalier in the *Ordre des Palmes académiques*, Mr. Archibald is a member of the *Conseil supérieur de la langue française*, the International Standards Organization's committee on translation and terminology and the *Office des professions du Québec*.

Martin Reisigl, University of Vienna, Austria



Martin Reisigl (PhD in Applied Linguistics) is an Assistant Professor (with tenure track) at the Department of Linguistics at the University of Vienna. Between 2011 and 2017, he has been an Assistant Professor for Sociolinguistics at the University of Bern. He was a Substitute Professor for German Linguistics at the Technical University Dortmund in 2016/2017 and at the University of Hamburg in 2009/2010. Furthermore, he was a Visiting Professor at the Central European University in Budapest (2009 and 2011). His research interests include (Critical) Discourse Analysis and discourse theory, text linguistics, sociolinguistics, pragmatics, politolinguistics, ecolinguistics, rhetoric, argumentation analysis and semiotics. His publications include *Discourse and Discrimination* (with R. Wodak; 2001), *Nationale Rhetorik in Fest- und Gedenkreden* (2007), *The Discursive Construction of National Identity* (with R. Wodak, R. de Cillia, K. Liebhart; 2009), *DiskursNetz. Wörterbuch der interdisziplinären Diskursforschung* (with D. Wrana, A. Ziem, M. Nonhoff, J. Angermüller; 2014), *Diskursforschung. Ein interdisziplinäres Handbuch* (with J. Angermüller, M. Nonhoff, E. Herschinger, F. Macgilchrist, J. Wedl, D. Wrana, A. Ziem), *Diskurs – semiotisch* (with E.W.B. Hess-Lüttich, H. Kämper, I. H. Warnke; 2017).

Srikant Sarangi, Aalborg University, Denmark



Srikant Sarangi is Professor in Humanities and Medicine and Director of the Danish Institute of Humanities and Medicine (DIHM) at Aalborg University, Denmark (www.dihm.aau.dk). Between 1993 and 2013, he was Professor in Language and Communication and Director of the Health Communication Research Centre at Cardiff University (UK), where he continues as Honorary Professor. Currently he is also Adjunct Professor at Norwegian University of Science and Technology (NTNU), Trondheim (Norway), Visiting Professor at University of Jyväskylä (Finland) and Visiting Professor at the College of Medicine, Qatar University. Between 2013 and 2016, he was Visiting Research Professor, Centre for the Humanities and Medicine, The University of Hong Kong, and since 2013 he has been Visiting Professor under the Academic Icon scheme at University of Malay. Over the last twenty years, he has held visiting academic attachments in many parts of the world.

In 2012, he was awarded the title of 'Fellow' by the Academy of Social Sciences, UK. In 2015, he was elected as a 'Foreign Member' of The Finnish Society of Sciences and Letters (*Societas Scientiarum Fennica*).

His research interests include: institutional and professional discourse from an applied linguistics perspective (e.g., health, social welfare, bureaucracy, education etc.); communication in genetic counselling, HIV/AIDS, telemedicine, primary care and palliative care; communication ethics; teaching and assessment of consulting and communication skills; language and identity in public life; intercultural pragmatics. He has held several project grants to study various aspects of health communication.

He is author and editor of twelve books, guest-editor of eight journal special issues and has published more than 250 book chapters and journal articles in leading journals. In addition, he has presented more than 1000 papers (including plenaries, keynotes, masterclasses and workshops) at international conferences and other forums.

He is the editor of *TEXT & TALK: An Interdisciplinary Journal of Language, Discourse and Communication Studies* (formerly *TEXT*) as well as founding editor of both *Communication & Medicine* and *Journal of Applied Linguistics and Professional Practice* (formerly *Journal of Applied Linguistics*). He is also general editor of the book series *Studies in Communication in Organisations and Professions* (SCOPE). He serves as an editorial board member for other journals and book series[es], and as a consulting advisor at many national and international levels.
