ACKNOWLEDGED THAT the Academic Senate of 13 July 2021, further to previous resolutions,

considering the protocol issued by the Presidency of the Council of Ministers on 15 April 2021 regarding the carrying out of public competitions, and considering that at the moment it is not possible to exclude a new emergency situation for the month of September, has resolved that the examination for admission to doctoral courses for the XXXVII cycle in the academic year 2021/2022 will consist of an oral test to be to be carried out online, which will also include an assessment of compatibility with the disciplinary areas of the doctorate



DECREES

Article 1 – Scope of the Call and general regulations

This Call lays down procedures for accessing the following doctorate courses for the academic year 2021/2022, XXXVII cycle:

Article 2 – Entry Requirements

Application is open, without limitations on age and citizenship, to all those who possess the educational qualifications required by the current legislation:

- degree taken in accordance with the regulations that were in force prior to the reform pursuant to Ministerial Decree no. 509/1999;
- specialised degree taken in accordance with Ministerial Decree no. 509/1999 or a Master's Degree taken in accordance with Ministerial Decree no. 270/2004;
- second-level academic qualification awarded by an institution in the AFAM category (Institutes of Higher Studies in Art, Music and Dance);
- academic qualification obtained overseas, on condition that it is comparable in duration and level to the Italian qualification so as to allow access to the course, and whose suitability has been checked in advance by the Academic Board for the sole purpose of granting admission to the competition, in compliance with current legislation on the recognition of qualifications for the continuation of studies.

Graduands are permitted to enrol *sub condicione* subject to obtaining their qualification by the deadline of 31 October 2021, otherwise forfeiting admission if the selection process is positive.

Stateless persons are considered equivalent to foreign nationals not belonging to the Member States of the European Union.

All candidates are admitted conditionally to the selection procedure.

The Rector may at any time exclude a candidate for substantiated reasons for failing to satisfy the prescribed requirements. This decision will be communicated to the interested party by a registered letter with return receipt.

Article 3 – Application for Admission

The application for admission, together with qualifications held, and any documents or publications deemed useful for the selection process, must be presented online, under penalty of exclusion, using the dedicated online application procedure to be found at: https://pica.cineca.it/iulm/

The application requires candidates to be in possession of an e-mail address for self-registration. They must enter all the data required for generating the application and attach the documents in PDF format.



No other method for submitting applications or documentation needed for participation is permitted.

Up to the application deadline, the system allows you to save in draft mode. The date of the online submission of the application for participation is certified by the computer system by means of a receipt that will be automatically sent by e-mail. Once the deadline for submission has expired, the system will no longer allow you to access or send the online form.

Each application will be assigned an identification number which, together with the competition code indicated in the online application, must be specified for any subsequent communication. The procedure for filling in and sending the application online must be completed by 12 noon on 3 September 2021, the University accepts no responsibility for any malfunctions due to the overloading of networks or application systems.

The procedure for submitting applications must be completed as follows:

- by digital signature, using a smart card, USB token or remote signature, allowing the holder to sign generic documents using PC signature software or a web portal for Remote Signatures made available by the Certifier. Those who have a smart card or a USB Digital Signature token will be able to verify its compatibility with the Digital Signature system integrated in the server system. In case of a positive outcome, the holder will be able to sign the application directly on the server (e.g. ConFirma);
- those who do not have compatible digital signature devices and Remote Digital Signature Holders who have access to a portal for the signing of generic documents, will have to save the PDF file generated by the system on their PC and, without modifying it in any way, digitally sign it in CAdES format: a file with the extension .p7m will be generated and will have to be uploaded again to the system. Any modification made to the file before making the Digital Signature will prevent the automatic verification of correspondence between the content of this document and the original and this will result in the exclusion of the application;
- if it is impossible to use either of the above options, the candidate must save the PDF file generated by the system on their PC and, without modifying it in any way, print it and add their full signature on the last page of the printout. This complete document must be scanned in PDF format and the resulting file must be uploaded to the system.

In implementation of the rules on self-certification, the University will proceed to verify the truthfulness of the self-certification and declarations in accordance with the Consolidated Act no. 445/2000.

All parts of the application form must be filled in following the instructions for the online procedures, and must compulsorily include:

- curriculum vitae et studiorum, signed at the bottom, which must analytically describe the candidate's research career (professional qualifications, scientific achievements etc.). The curriculum vitae is valid as self-certification pursuant to Articles 46 and 47 of Presidential Decree 445/2000 as regards possession of the qualifications specified therein;
- degree thesis;
- the research project related to the aims of the doctorate course which will be the subject of the interview for admission to the course. The research project will have to illustrate: topic, objectives, research problems, methodology and timing of the research and contain an initial bibliography describing the latest developments in the area of research;
- any publications complete with identifying data (authors, title, journal/book, number of pages, year of publication);
- copy of a currently valid identity document;
- copy of the payment of €100 relating to the pre-enrolment fee for the competition to be made by bank transfer to:

The pre-enrolment fee will not be refunded in the case of not being admitted to the courses or giving up a place on them.

Candidates may also attach the following to their application:

- any other document deemed suitable to prove professional qualifications, scientific output and aptitude for research;
- any other qualifications and certification that the applicant considers appropriate to present;
- a list signed by the candidate of all the documents and qualifications presented.

The research project discussed during interview is not binding when assigning the actual research topic if admitted to the course.

Pursuant to law no. 104/92 as modified by law no. 17/99, candidates with disabilities may obtain additional time and/or aids to carry out the competition examination. For this purpose the candidate needs to make a specific request in the application.

Under the terms of Article 75 of Presidential Decree no. 445/2000, if the Administration discovers, on the basis of its appropriate checks, the untruthfulness of the content of the declarations made by the candidate, he/she will lose the benefits granted by the measure issued on the basis of an untruthful declaration.

Data will be processed in accordance with Legislative Decree no.196 of 2003 (Personal Data Protection Code), as amended, and Regulation (EU) 2016/679 (General Data Protection Regulation).

Article 4 – Academic Board

The Academic Board for the admissions examination is formed and appointed in line with the existing Regulations. It is made up of three members chosen from the full professors and associate professors, at least one of whom is a full professor and at least one is external, belonging to Scientific Disciplinary Sectors relating to the doctorate. The most senior professor will act as Chair, the youngest professor in the role will act as Secretary.

Article 5 – Entry examination

The entry examination for the course consists of an oral test aimed at assessing the candidate's background, skills and aptitude regarding scientific research: the test consists in the discussion of the project presented, illustrating the candidate's research activity (for this purpose, any publications and/or qualifications presented by the candidate will be taken into consideration, giving preference to training or study courses carried out abroad) as well as its compatibility with the disciplinary areas of the doctoral programme. The Board may ask the candidate general questions so as to allow them to demonstrate knowledge of relevant disciplinary areas. The oral test includes verification of the candidate's knowledge of English, while for foreign candidates assessment will be made of their knowledge of Italian.



The oral test will take place online, with suitable IT support made available by the University, using procedures that guarantee the identification of the candidates, the equality of candidates and the regularity of the procedure.

The oral test will be preceded by the evaluation of qualifications and publications; the result of the admissions procedure will be published on the University website together with the test schedule, indicating the day and time of the interview for the admitted candidates.

The schedule of the days and times of the tests will for all legal purposes constitute the official invitation to attend.

Any variations to the schedule, indicating the day, month and time – if different from those indicated in this Call for Applications – will be communicated to the candidates by registered post with return receipt seven days prior to the new date or, in cases of need and urgency, within a shorter period of time by telegram with advance notice sent by e-mail or PEC (certified e-mail).

The University accepts no responsibility for failure to receive communications if the candidate has provided incorrect information about their place of residence and address, or for the lack of or late notification of a change of address, or for any postal or telegraphic difficulties that cannot be considered the Administration's fault.

The remote interview will take place on the TEAMS platform, for which purpose the candidate must indicate an e-mail account that the Academic Board will use for the video call.

The candidate must be available at the personal address indicated in the application form on the day and time set for the oral test. For identification purposes and on penalty of exclusion from the competition, candidates must identify themselves before the interview begins by producing the same identity document as attached to the application, of which a copy will already have been forwarded. The candidate may be excluded from the competition if they have not provided their personal e-mail address, if they are unable to connect, if they cannot be contacted on the fixed day or time, or if they do not produce a valid identity document.

The University declines any responsibility in the event that technical reasons prevent the proper carrying out of the interview.

Anyone other than the candidates interested in being present as an attendee may send an e-mail request using the form published on the University website https://www.iulm.it/it/offerta-formativa/dottorati-di-ricerca. The request will be forwarded to the Board so that the contact details of the person concerned can be added to the contact details of the admitted candidates. Under penalty of being expelled from the online session, the interested party will be admitted to participate with the microphone switched off. Audio-video recordings are not permitted during the session.

Article 6 – Completion of selection procedure

The Board can award a total of 50 points. A maximum of 20 points will be reserved for the evaluation of qualifications and publications, which will be carried out before the oral test takes place; the score for admission to the next stage must be no less than 14 points.

A total of 30 points will be awarded for the oral test. The pass mark for the test will be no less than 20 points.

The final mark will be the sum of the points awarded for the assessment of qualifications and publications, and of the points awarded for the evaluation of the oral test.

Each Board shall draw up merit-based rankings on the basis of a comparative assessment of the candidates to be admitted to the chosen doctorate course in the order of their ranking until the number of places available have been filled. The study grants will be assigned in accordance with the ranking order. In case of equal performance an assessment of the financial situation determined in accordance



with current legislation regarding the right to study shall prevail. In case of further equal performance the youngest candidate shall prevail.

The places not covered by study grants are awarded to eligible candidates until all available places have been assigned. In case of equal performance, the youngest candidate shall prevail.

In case of selected candidates giving up their right prior to the beginning of the course, they will be replaced by the same number of candidates selected according to the order of the ranking.

On completion of the selection process the Ufficio Affari Istituzionali will communicate the outcome of the competition by registered post with return receipt. The candidates admitted to the course shall be excluded if they do not offer their acceptance within **seven days** of receiving the communication. In this case another candidate shall replace him/her according to the order of the ranking.

In case of a doctorate student in possession of a grant giving up the course or being dismissed, he/she shall lose the right to the benefit of the grant for the non-accrued amount, with the obligation to repay the amount already received in the year in question, except for justified and proven reasons. The remaining part of the grant, if it is equal to or greater than eighteen months, may be awarded to the first of the candidates in the ranking order not to have been awarded a grant. In this case the instalments for admission to and attendance on the doctorate course, owed subsequently to the substitution, do not have to be paid by the replacement student.

Article 7 – Fees for Entry to and Attendance on the Courses

With regard to the places available for the competition that are not covered by study grants, the admitted candidate will be required to pay fees for entry to and attendance on the doctorate course for the academic year 2021/2022 of €1,500.00 for each year, divided as follows:

1st instament: (upon enrolment) €800.00, including the sum of €100.00 already paid for the competition pre-enrolment fee;

2nd instalment: €350.00 (by 31 December 2021); 3rd instalment: €350.00 (by 31 March 2022)

not including the regional tax for the right to study, which is currently set at €140. The amount of the tax will be confirmed after its definition by the Regione Lombardia for the academic year 2021/2022.

Article 8 - Study Grants

The study grants are awarded according to the ranking set out in the comparative assessment of Italian and EU candidates, or non-EU but resident in Italy, or holders of a residence card, that is the Permit to Stay ["permesso di soggiorno"] for one of the reasons given in Article 37, paragraph 5, of Law no. 40 of 6 March 1998, with an overall annual income not greater than €80,000.

All income from assets is included in the calculation of income as well as earnings of any other nature. The amount of the grant is determined under the terms of Article 1, para 1 letter a), of Law no. 315 of 3 August 1998, as amended. In cases of equal performance what shall prevail is the evaluation of the economic situation determined under the terms of the Prime Ministerial Decrees of 30 April 1997 and 9 April 2001, as amended.

The grants, which amount to €15,343.28 gross of social security charges payable by the doctorate students, are paid in monthly instalments in arrears and are for the entire length of the course (three-years). The amount is increased by 50% for any documented consecutive periods of study abroad lasting more than 21 days, for an overall maximum total of 18 months if these are part of the doctorate project and are in accordance with the Regulations.

If the doctorate student does not receive a positive evaluation for renewal of the grant, or gives it up, the unused amount remains at the University's disposal for the same purposes. Doctorate students with a study grant are exempt from paying the fees due for admission and attendance on the courses. The study grant is subject to the payment of INPS (state health insurance scheme) contributions under



the terms of Article 2, paragraph 26, of Law no. 335 of 8 August 1995, as amended. Doctorate students shall enjoy the benefits of related health coverage and rights.

The period of holding the grant and therefore the reference point for calculating the income for the academic year 2021/2022, is the calendar year 2020.

Article 9 - Regional Benefits for IULM University

Doctorate students can take advantage of the benefits made available as part of IULM University's right to university study activities, in accordance with the provisions of the Prime Ministerial Decree of 9 April 2001 (and any subsequent amendments) and Legislative Decree no. 68 of 29 March 2012. The DSU Office of IULM University establishes the limits and procedures for doctorate students' access to the benefits and defines the list of eligible candidates. Article 10 - Documents

The candidates admitted to the course must submit application for enrolment on the course within the final deadline of **seven days** from the day following receipt of notification of the outcome of the competition, enclosing the following documents:

- a) a duly signed photocopy of an identity document;
- b) self-certification of citizenship;
- c) self-certification of the secondary school leaving qualification or, for non-EU citizens, the diploma which allowed their admission to university, duly translated and legally authenticated by relevant Italian overseas representatives according to the legislation in force for the admission of overseas students to degree courses in Italian universities;
- d) self-certification of four-/five-year degree or second cycle degree with related grades;
- e) in case of enrolment to a specialist professional school, or to another university course in Italy or abroad, the written undertaking to suspend attendance;
- f) declaration of not having previously benefited from other doctorate study grants, if they are beneficiaries:
- g) self-certification of overall personal income for 2020 in the case that applicants intend to benefit from a study grant as in Article 8 above;
- h) declaration of being/not being employed in Public Administration and, if that is the case, to have requested leave of absence with or without benefits running from the date of the start of the course for its entire length.

The self-certification must be replaced by appropriate certificates in the case of non-EU citizens. The acts and documents drawn up in foreign languages must be translated and legally authenticated by the relevant overseas Italian diplomatic or consular representatives in compliance with the measures in force in the State itself.

The winners of the competition are obliged to pay the stamp duty due on their application to render it valid.

Article 11 – Obligations and rights of doctorate students

Within the scope of the right to study a doctorate student is a university student enrolled on a postgraduate course and treated in the same way as students enrolled on first and second cycle degree courses. Admission to a doctorate course normally entails compulsory attendance at lessons and



teaching activities scheduled by the Doctorate Board, without prejudice to the possibility of specific conditions in relation to students enrolled pursuant to article 19, paragraph 3 of the University Regulations for research doctorates and to students enrolled on courses activated pursuant to article 4, paragraph 1) letter c) of the aforementioned Regulations.

Enrolment on the research doctorate courses is incompatible with the contemporaneous enrolment in Italy or abroad on first or second cycle degree courses, university Master's courses, other doctorate courses and in postgraduate professional schools in Italy or abroad, without prejudice to agreements regarding the joint supervision of theses. In this case students enrolled on these courses who, being in possession of the required qualification, intend to enrol on a research doctorate course, are obliged to ask for a temporary suspension of said courses. It is also forbidden to benefit simultaneously from other study grants, excluding those granted by Italian or foreign institutions for integrating foreign stays with training and research activities for doctorate students.

Doctorate students, as an integral part of the course project, may carry out, on condition that they receive authorisation from the Doctorate Board and that it does not result in an increase in the study grant, tutoring activities for undergraduate students on first and second cycle degree courses and also, but for a maximum of forty hours each academic year, the teaching of seminars. These commitments shall in no way compromise the study of research activities. The teaching shall be optional with no costs to be borne by the University and shall not lead to any rights in accessing roles within the University. Doctorate students shall have an obligation to confidentiality regarding the research activities in which they participate.

In the case of grant recipients, enrolment on the course and attendance are, as a rule, incompatible with employment contracts. In any case it shall be the responsibility of the Doctorate Board, after consultation with teaching staff, to provide prior authorisation for doctorate students to carry out any form of work.

For doctorate students without a study grant the Doctorate Board, after consultation with teaching staff, shall in any case provide prior assessment regarding any incompatibility that may arise from employment activities, and provide a specific ruling.

For both categories of doctorate students any form of work carried out must be relevant to the objectives of the doctorate course and must be relevant for the acquisition of skills related to the training objectives of the doctorate course itself. The final decision shall be taken by the School Director.

Starting from the second year, each doctorate student may be funded, in addition to the study grant and within the existing financial resources in the budget, with a budget for research activities in Italy and abroad appropriate to the type of course, and in any case for an amount of not less than 10% of the amount of the scholarship to be paid, following the presentation of suitable proof of the costs incurred.

Public employees admitted to a doctorate course shall benefit, for the normal period of the course, from the period of leave of absence agreed upon as part of collective negotiations or, for employees with contracts governed by Public Law, from extraordinary leave of absence for study reasons, in accordance with the administration's needs and requirements, pursuant to article 2 of Law no. 476 of 13 August 1984, as amended, with or without payment cheques and excepting any specific waiver, only in the case that they have enrolled for the first time on a doctorate course, and regardless of the subject area.

Should a student decide not to continue their studies, they shall communicate their decision to the School Coordinator and Director providing one month's notice.

The start of activities relating to doctorate courses, without prejudice to the provisions of Article 8, paragraph 5 and Article 11 of Ministerial Decree no. 45 of 8 February 2013, is scheduled for November 2021.



Article 12 - Processing of personal data

In compliance with the provisions of Regulation (EU) 2016/679 (General Data Protection Regulation), we hereby provide the following information regarding the processing of the personal data provided.

1. DATA PROCESSORS

The DATA CONTROLLER, pursuant to Articles 4 and 24 of Regulation (EU) 2016/679 is the Libera Università di Lingue e Comunicazione IULM, located in Via Carlo Bo, 1 - 20143 Milano, represented by its pro-tempore legal representative.

In compliance with Articles 37-39 of Regulation (EU) 2016/679, the Unversity has appointed a Data Protection Officer (DPO) who can be contacted at the following e-mail address: dpo.iulm@dpoprofessionalservice.it.

2. PURPOSES OF PROCESSING AND LAWFUL BASIS

The personal data provided will be processed in accordance with the *conditions of lawful basis* pursuant to article 6, letters b), c) and e) of Regulation (EU) 2016/679 for the following purposes:

- to submit an application to take part in the competition for admission to doctorate courses;
- to allow the University to verify possession of the requisites needed to carry out selection procedures;
- to allow the University to manage the selection procedure, in all its phases, including the publication of results and rankings on its website.

In the event of admission to the doctorate course, the same data will be used for the management of teaching and administrative relationships between the University and the doctorate students.

3. RECIPIENTS OR CATEGORIES OF RECIPIENTS OF DATA

The personal data provided may be communicated to recipients, appointed pursuant to article 28 of Regulation (EU) 2016/679, who will process the data in their capacity as Data Processors and/or as natural persons acting under the authority of the Data Controller and the Data Processor, in order to fulfil contracts or related purposes. Specifically, the data may be communicated to recipients belonging to the following categories:

- providers of services for the management of the information systems and the communication networks of IULM University (including e-mail);
- internal structures of the University e.g. Departments, Doctorate School and teaching staff, Human Resources Office, Administration, Finance and Control Office, structures responsible for communication;
- firms or companies providing assistance and consultancy;
- competent authorities for the fulfilment of legal obligations, upon request;
- certifying authorities when checking declarations made for the purposes of Presidential Decree 445/2000;
- local authorities for the purposes of any benefits in favour of particular categories of doctorate students;

For administration and accounting purposes, the data may be transmitted to Business Information Services Companies for the assessment of solvency and payment habits and/or to providers of credit recovery services.

The subjects belonging to the above categories act as Data Processors or operate completely independently as separate Data Controllers. The list of designated Data Processors is constantly updated and available at the offices of the Libera Università di Lingue e Comunicazione IULM.

4. DATA TRANSFER TO THIRD COUNTRIES AND/OR INTERNATIONAL ORGANIZATIONS
