# CALLS FOR APPLICATION MOBILITY PROGRAM 2025


- In order to apply for ANY mobility call, you need to prove that you already have a level of language knowledge appropriate to the demand of the universities you are interested in;
- The compulsory language requirements are indicated in the «Destination sheets» attached to the various notices and subdivided by degree course;
- Until the publication of the Mobility Call 2025, for information only, you can view the international certifications or language levels required by individual destinations in the «Destination sheets» for the 2024 call for application;
- Announced destinations and language levels required by the partner universities may, however, change by 2025.

## IULM Language Proficiency Levels or International Certifications?



If in the Destination Sheet, only the general level is specified (B1/B2 etc.):

### **IULM Language Proficiency: validity**



#### The IULM Language Proficiency result is valid for two years



If you have obtained a IULM language qualification from ILC for the 2024 Calls for Applications (for the tests held in November 2023), you can also apply for the 2025 Calls for Applications for the same language and level, without taking any further tests.



International Certifications must be issued after **01.01.2023**.

Any certification issued before that date will not be accepted for the 2025 call for applications.


Passing exams or linguistic laboratories included in your IULM study program does not provide you either the IULM language proficiency result or the international certification.


To participate in the calls for applications, you will still have to pass the IULM language proficiency test or present an international language certificate.

## IULM Language Proficiency Levels or International Certifications?



If an international certification is indicated in the destination sheet, next to the University:





 The certification must still be valid at the time of departure for the destination (i.e. not more than two years old).

## **Erasmus Mobility Call - Exemptions**

Students enrolled in the Degree Programs taught in English, such as:



BA in Corporate Communication and Public Relations



MSc in Hospitality and Tourism Management



MSc in Strategic Communication



MSc in Marketing, Consumer Behaviour and Communication

are exempted from the English
Proficiency test for the
destinations requiring **English B2**. They still have to hold a
Language Proficiency test
result for the other languages.

Students enrolled in the Master's Degree in Specialized Translation and Conference Interpreting are exempted from the Language Proficiency Test for all the languages in their study plan.

In both cases, if a destination requires an <u>International certification</u>, the student must first obtain it in order to apply.

## **Exchange and Semester Abroad - Exemptions**



For some destinations only, students enrolled in the degree programmes "Corporate Communication and Public Relations" (English language curriculum) and "Hospitality and Tourism Management" are exempt from presenting an International Language Certificate.
