



Procedures for Renewal of Enrolment in Years Subsequent to the First Year

Bachelor's and Master's Degree Programmes

Academic Year 2026/2027

Applications for online enrolment in the second and third years of Bachelor's degree programmes and in the second year of Master's degree programmes for the academic year 2026/2027 must be submitted

from 15 July to 15 September 2026

with payment of the first instalment to be made by **15 September 2026** (applications submitted from 16 September to 30 November 2026 will be subject to a late-payment fee).

Enrolment may be renewed through the personal area of the [Servizi di Segreteria online](#), under the "**Registrations**" section.

When submitting the enrolment request, students must review the [Regulations for University Fees and Contributions for the Academic Year 2026/2027](#) applicable to students enrolled in Bachelor's and Master's degree programmes.

Students renewing their enrolment in years subsequent to the first year who believe they may be eligible for a tuition fee band other than the maximum band must obtain an **ISEE certificate for university benefits (ISEE Universitario)** and complete, by **27 November 2026**, the ISEE self-certification authorising IULM University to access the ISEE data held in the INPS database for the purpose of assigning the appropriate university tuition fee band.



Payment of the enrolment fee and contributions is divided into three instalments:

- First instalment: due by **15 September 2026**. The payment notice will be available in the Fees section of the *Servizi di Segreteria Online* from 15 July 2026.
- Second instalment: due by **14 December 2026** (the amount varies according to the assigned tuition fee band). The payment notice will be available in the Fees section of the *Servizi di Segreteria Online* from 2 December 2026.
- Third instalment: due by **31 March 2027** (the amount varies according to the assigned tuition fee band). The payment notice will be available in the Fees section of the *Servizi di Segreteria Online* from 16 February 2027 (start of second-semester classes)*.

The amount of the second instalment will be increased by the balance of the Regional Tax for the Right to Study, where applicable. The three ISEE bands established by the Lombardy Region, as well as the corresponding amounts of the Regional Tax, are set out in Chapter 4 of the Regulations for Fees and Contributions for the Academic Year 2026/2027.

Any late payment will incur a penalty of €50 for individual payments below €3,000 and €100 for amounts above this threshold, in addition to the suspension of all academic and administrative services.

** Students who, after renewing their enrolment, decide to withdraw from their studies and submit a formal withdrawal application before the issue date of the second instalment (by 30 November 2026) or of the third instalment (by 15 February 2027) will not be required to pay the relevant instalment.*



Enrolment as an Out-of-Course ('Fuori Corso') Student

Bachelor's and Master's Degree Programmes

Academic Year 2026/2027

Applications for enrolment as an out-of-course student (Bachelor's and Master's degree programmes) for the academic year 2026/2027 must be submitted from **15 July 2026 to 28 February 2027** (applications submitted from 1 March to 31 May 2027 will be subject to a late-payment fee).

The procedure may be completed through the personal area of the [Servizi di Segreteria online](#), under the "**Registrations**" section.

The out-of-course enrolment fee must be paid in a single instalment.

Any late payment will incur a penalty of €50 for individual payments below €3,000 and €100 for amounts above this threshold, in addition to the suspension of all academic and administrative services.
